Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



To the Senate and House of Representatives of the State of South Carolina

The Humble Petition of John Burket [sic] of the District of Marlborough and State aforesaid Sheweth That soon after the commencement of the American Revolutionary War, he joined the militia service under the Command of Captain James Thompson (afterwards Colonel Thompson) on the Savannah River, under the command of General Lee [Charles Lee]. – That he remained on the said river and in the State of Georgia for nearly three Years.

That he was in a Battle on the Savannah River and at Briar Creek [March 3, 1779], with the British who were under the command of General Ashe,³ – That after the American Army had retreated from Georgia he returned to Pee Dee River and joined Captain Standard's [William Standard's Militia Company & Shortly afterwards was ordered to Charleston under the Command of Captain Stackhouse [John Stackhouse or William Stackhouse, both of the Cheraw District Militia] where he arrived a short time previous to the Surrender of that City [Charleston South Carolina fell to the British on May 12, 1780] – was taken Prisoner & paroled. That he returned home and immediately joined General Marion's Brigade while he was encamped at the Bowling Green he was Stationed at Cashaway Ferry [Cashua Ferry] to guard that Crossing on the Pee Dee River

That he marched with General Marion's Brigade to the Santee River –. That he remained with Marion's Brigade until they were discharged –. That during the whole time he was in the Service he faithfully & promptly discharged his Several and respective duties –. That your Petitioner is now eighty-five years of age and is poor and unable to work for the support & maintenance of himself and wife and prays that he may be placed on the pension list. And your petitioner will pray

Marlborough District By John J Stubbs one of the justices assigned to keep the peace in said District Personally appeared before me Mr. Joshua Ammons⁴ who after being duly sworn deposeth as follows: viz.: That he knows John Burkett to have served some considerable time in the revolutionary war if not during the whole of the revolutionary contest. But states that he cannot distinctly recall the different officers that he served under during all the time that he was in the Army, But that he was with General Marion a great part of the time.
