Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

² Both Matthew Singleton and Richard Singleton were Lt. Cols in the Camden District Regiment of militia from the St. Mark's Parish. Matthew Singleton, however, is the only one of the two who is believed to have been at the Siege of Charleston, so he is the more likely of the two to be the officer referred to in this claimant's claim. Matthew Singleton was serving as Lt. Col. of the Berkeley County Regiment under Francis Marion at the time of the Siege of Charleston.

It is clear from the documents in this file that she is the widow of James Borrough above. Among the documents in the file is one signed by her as follows:
