Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable David Ramsey President of the Senate & Members of that Honorable branch now in Session at Columbia

The Memorial of Captain William Caldwell Humbly Sheweth

That your Memorialist having served as a Captain in the Army of the United States in the late war was made a prisoner of the Enemy and that during the time he was prisoner, before his Exchange took place, he has not received either Continental nor additional State pay although he did actually return his whole Account – (which accompanies this Memorial) to James McCall Esquire Auditor General of this State to be Audited, before he was barred by law from Auditing the same, but no part of your Memorialist's said Account was audited neither his Claim against the United States nor the additional pay allowed by this State as aforesaid – Therefore your Memorialist is emboldened to come forward Humbly to request Relief from your Honorable House in the way that you may think Right – and your memorialist as in duty bound will pray
