Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Petition of Ann Cannon

Sheweth

That your Petitioner's Husband William Cannon was killed in July 1781 by the Tories [paper torn and words obliterated] defending his country that she is still a Widow & owns neither lands or Negroes by which he can support herself without applying to the Bounty of the legislature for the Annuity provided for Widows in her situation. Only referring to the Bo[word cut off, "Books" is the likely word] of the Treasury it will appear that she has formally drawn some money on the above Account but for several years past from her ignorance [of] the mode of application she has not received the annual Allowance. She therefore Prays the Legislature to take her Case into their consideration & grant her whatever Arrears may be found due her which if granted will make her old age happy & comfortable

Ann Cannon has been paid on account of Annuities Fifteen Pounds in May 1794 – but she cannot receive any further Payment unless the Legislature directs it, she having made application subsequent to 1 June 1793 – she must petition the House – see Resolution of December 9, 1794 – She was paid said Sum (£15) by B. W. Tr.
