[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Samuel Carson also made oath before me that the black horse with a large Star, branded on the near buttock & something like where the original obliterated appraised the above at £21.5 Sterling he lost in the Public Service about the last of September 1780, when retreating from the first siege of Augusta<sup>2</sup> & also that a Sorrel horse with a Blaze, both his hind feet white, no brand remembered, also his just right & property was stole or lost at the last siege of Augusta<sup>3</sup> about the last of May 1780, appraised the above at £28.5.6 Sterling – which horses were both lost in the Public Service as aforesaid, & not through any carelessness, neglect or misbehavior of him the said Deponent, & that notwithstanding his best endeavors he has never since got either of the said horses, or any restitution in lieu thereof

To the Honorable the President & Members of the Senate of the State of South Carolina The Petition of Jane Moore [sic] formerly the Widow of Samuel Carson of old Ninety Six District in behalf of herself & the other Heirs of the said Samuel Carson humbly Sheweth.

That your petitioner's former husband Samuel Carson left on account against the State for this sum of £50.0.6 Sterling which appears to have been properly attested & certified the year 1784 & which is herewith presented Whether the same has ever been returned to the proper Officers of this State, or not is unknown to your petitioner, her Husband dying shortly after the Account was made out, & she being a poor ignorant Woman has never made any proper application for her Right (or at least if any has been made, it is unknown to her) But she hopes the length of time will not ban her Just claim, under her peculiar circumstances. She therefore hopes, the Honorable Legislature will take the case into consideration, & grant such sum as to Justice doth appertain. And your petitioner as in duty bound will ever pray

The Comptroller General again respectfully takes leave to suggest to the legislature the propriety of barring Claims of such long-standing as it is extremely difficult at this day to obtain Evidence of the payment of such demands

Your petitioner Jane Moore [sic] formally Jane Carson humbly Sheweth – that her former husband Samuel Carson – was one among the first to assert and assist in the obtaining the Independence of the United States of America – and that he served almost constantly in the different Campaigns under the officers Engaged in defense of this country and that your petitioner's husband took very sick at the siege of Augusta – and after lingering for some time died and left your petitioner to mourn his loss and the loss of nearly all her property which had been taken by the Tories – and that the officers under whom he served did make out a return of the services which Indent has been drawn by some person unknown to your petitioner and that after repeated trials your petitioner cannot recover[?] her Indent –

Your petitioner prays your Honorable Body to place her on the pension list and thereby prevent her old gray hairs from going down to the grave which it soon must do with sorrow – and your petitioner as in duty bound will ever pray
