Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the President & other Honorable Members of the Senate. The humble petition of Benjamin Carter humbly Sheweth That he is an old Soldier of the revolution and served faithfully to the end of the War. Your Petitioner further Sheweth that at the battle of Stono [June 20, 1779] he was severely wounded but having recovered he again rallied under the standard of liberty, and while his youth and health continued he was enabled to support his family by labor – But your Petitioner now is an old man and the springs of life are nearly worn out and being in indigent circumstances he appeals to the justice & magnanimity of that Country in whose services he has exhausted the [indecipherable word] of his manhood & begs your Honorable body to grant him two years arrearages of pensions and place him upon the list as a pensioner of this State & as in duty bound your Petitioner will ever pray.



To the Honorable the President and other members of the Senate The petition of Jacob Hess and Elizabeth his wife respectfully Sheweth

That the said Elizabeth is the daughter of Alexander Brunson who was regularly enlisted as a soldier in the Revolutionary War and was killed at the close of the same by Tories. That the said Elizabeth intermarried with George Polan and by him had eight children of which six are still alive and after the death of Mr. Polan she intermarried with Benjamin Carter on the 18th January 1820 and by him had one child now live and four years of age.

That the said Benjamin Carter reported this life on the 9 July 1826 having received in the close of life, when he was aged and infirm a pension from the State for his Revolutionary services up to the 1st of March 1826, commencing about two years preceding his death as will appear from the Records of Your Honorable Body.

That the said Elizabeth afterwards intermarried with the said Jacob Hess and being now in great want and distress and having two of her said children one aged ten years of age and the other four years of age to maintain and support without any other means that in the monthly pay of her husband as a member of the City Guard, which amounts to \$16 per month and what she is able to earn with her needle, she and her said husband Your petitioners solicit the Compassion of Your Honorable Body and pray that they may be allowed the amount of the Pension granted to the said Benjamin Carter from the first of March 1826 (to which period he had been paid up) to the 9th of July 1826, when he departed this life and such other aid and relief as Your Honorable Body may be disposed to grant them. And your Petitioner as in duty bound will ever pray and so forth.
