Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Senate and House of Representatives of the State of South Carolina The Humble Petition of William Carter

Sheweth

That whereas your Petitioner was badly wounded through the Breast and Hip at the Eutaw Springs fighting for his Country in General Green's [Nathanael Greene's] Army on the 8th day of September, in the Year 1781, as a private Soldier in Captain Robert Thornley's Company, Colonel John Erwin's Regiment and General Francis Marion's Brigade of Militia, which wound disabled your Petitioner from acquiring his living, and supporting his family by hard labor, that your petitioner has never before applied for assistance from the Public, owing to a wish and desire, with his best endeavors to support himself, and family, which he finds at present, he is not able to do: that your Petitioner is not possessed of property sufficient to support his family, which consists of three Children – Your Petitioner therefore prays that your Honorable House would be pleased to consider his distressed situation and grant him such relief as is afforded to others, in the same situation – and your Petitioner will ever Pray &c Liberty County, November 20th 1797

State of South Carolina George Town District Appeared before me William Carter who maketh Oath on the Holy Evangelist of Almighty God, that he was an inhabitant of the said District before January 1785 that he was wounded by the British Troops at the Eutaw Springs in the year 1781 under the Command of General Marion that he was a friend of his country when wounded, and that the wound has disabled him from Acquiring his Livelihood as formerly, that he does not on either Negroes or Land, which would disqualify him from obtaining the annuity due him by Law, from March 1786 and that he was in the Militia Service from the beginning of the war till he was wounded.

Please to pay one Charles Barefeets [?] the sum of 10 pounds due to me from the public Treasury of South Carolina for the year 1779 or 1799 as I was enrolled on the pension list in December 1798 and you will oblige your humble servant October 22nd, 1799 S/ William Carter

To the Honorable the Speaker, and other members of the House of Representatives of the State of South Carolina at Columbia Assembled – the Petition of William Carter humbly Sheweth – That your Petitioner was a soldier in the late revolutionary war; served under General Marion, and at the battle of the Eutaw was dangerously wounded in his body by a musket ball from the

British – in consequence of which he suffered extremely fourteen months – that he has not at any time since he was wounded possessed two Negroes; but only a small tract of land – that the wound he received rendered him unable to support himself as formerly that he is now advanced in years, & has a wife and three children to support – that your Honorable body in the year 1799 placed him on the Pension list, since which time he has annually been paid a pension – that he humbly conceives he was justly entitled to a pension from the time he received his wound, until the year 1793; which liberality has been extended to many under circumstances similar to his own – that he presumes he is not being placed on the pension list sooner was owing to his ignorance of the proper time and mode of application, & not to any want of justice or feeling on the part of the Legislature – He therefore humbly prays your Honorable body to take his case into consideration and to allow him the same payable heretofore as has been heretofore allowed to other wounded and disabled though faithful friends and service of their country – & your Petitioner in duty bound will ever pray &c

That they have carefully considered the same, and by the documents accompanying it, appears that the said Carter was wounded in the battle of Eutaw, being shot by a musket ball through the body in consequence of which he has been rendered incapable of supporting himself and family.
