[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Speaker & Members of the house of Representatives The humble petition of James Hood Sheweth to your Honorable body, that after the days he has spent in the hard Service of his Country during the Revolutionary [war], it will not be thought [indecipherable word or words]<sup>2</sup> in him to claim a charity from the Legislature of his Country – The prime of his life was devoted to a Cause that has given to you freedom & happiness & has enabled you to Legislate for a wise & generous people independent of foreign control or influence. Now that he is old & past doing anything for himself save to implore your zealous appreciations of the merits of the old soldiers will induce you to lend to your Petitioner a helping hand in need. The first tour your Petitioner service was under Colonel Kershaw [Eli Kershaw] at Purrisburg. The next after of the fall of Charleston [Charleston South Carolina fell to the British on May 12, 1780] was with General Sumpter [Thomas Sumter] when he made his Campaign in the Indian Land, & when he fought at the Rocky Mount [July 30, 1780] & at the hanging Rock [August 6, 1780], your Petitioner was placed as a Guard with the baggage Wagons, When General Sumter was defeated [Battle of Fishing Creek, August 18, 1780] on the Catawba [River], your Petitioner was there – at Friday's Ferry [May 1, 1781] (now near Columbia) where a firing was kept up for a day & night your petitioner was there & continued under General Sumter during the whole of his rounds; In the lower part of this State at the Scott Lake [Fort Watson, February 24, 1781] where there was a Sharp Skirmish your Petitioner was present. He was in 2 Skirmishes at Colonel Thompson's [William Thomson's] where there were about sixty prisoners taken. He was in various other Skirmishes in this State and in all endeavored as far as he could to aid in the great Cause. Your Petitioner afterwards served under General Marion [Francis Marion] was with [him] at the engagement at Parkers Ferry [August 31, 1781] on the Edisto River – & was with him at the Battle of the Eutaw spring [Eutaw Springs,

September 8, 1781]. Your Petitioner states that he is now nearly seventy years of age, has a wife about his own age is poor & needy of assistance – Your Petitioner therefore prays that your Honorable [Body] would place him on the pension roll & he will ever pray
