The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2] Petition of Nancy Chapman for a pension

To the Honorable the Senate and House of Representatives of the State of South Carolina –

Your petitioner most respectfully represents that she is the Widow of Thomas Chapman deceased a soldier in the revolutionary War under the command of Colonel Manning [sic, probably Captain Lawrence Manning] – that her deceased husband was honorably discharged at the close of the War – that he afterwards placed in the hands of his gallant Commander the necessary papers to procure for him a pension at the hands of the Federal government – that his said Commander departed this life before the object was obtained and in consequence thereof he the said Thomas Chapman never could regain the possession of his papers –

Your petitioner further represents that she is now over Eighty years of age and in destitute circumstances and must respectfully ask that such pecuniary aid as your honorable body may be pleased to grant, be extended to her for the few remaining days of her stay on earth –

Your petitioner further represents that she was married to the said Thomas Chapman during the progress of the Revolutionary war but at what particular period she does not now exact I remember.

That your honorable body may grant the relief sought for in the humble prayer of your petitioner.
