Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The Petition of John Chavis a free man of colour praying to be placed on the Pension List

To the Honorable the President and Members of the Senate of South Carolina

Sheweth

That your Petitioner sometime in the year 1780 enlisted in Captain Mattock's [David Mattock's] Company and that he served in said Company and the Company of Captain Cronicle [William Chronicle]² until near the close of the war when he was discharged on account of the many wounds he received in an engagement with some Tories near the North Carolina line at a place called Ramseur's [Ramseur's Mill, June 20, 1780].³ Your Petitioner is now old and by reason of the said wounds is unable to support himself by his Labour and therefore prays your Honorable Body to place him on the pension list, and your Petitioner as in duty bound will ever pray

State of Georgia Effingham County} Personally came before me Benjamin Kennedy One of the Justices of the said County Jacob Solter⁴ who being duly sworn deposeth and saith that he was well acquainted with John Chavis and that he was in the regular Service in the old revolutionary war under the command of Colonel Tomson [William Thomson of SC] and then General Linchorn [Benjamin Lincoln] & he further Deposeth and saith that he has taken on Oath previous before Chrⁿ Keulten [?] Esqr. in behalf of said John Chavis, which he has taken an oath before Alexander McGrew that he lost which he wishes me to furnish him with another affidavit as he could not obtain a copy of the former Oath taken before Esquire Keulten –

To the Honorable the Speaker and Members of the House of Representatives

The Petition of Joseph Streable Humbly Sheweth, that about the year 1823, John Chavis a free man of colour applied by petition to your Honorable body for to be placed on the pension list for his many services, and severe wounds he had received in the revolutionary war, the said petition was reported favorably on by the committee in Senate, and he was only denied it being granted in consequence of his not having appointed a guardian (which law he was ignorant of) previously to such application, this circumstance together with a letter given the said John Chavis by the then members of your Honorable body from one Parish saying there was no doubt he would get the pension at the next Session of the Legislature, this letter was written for the express purpose of keeping the aforesaid John Chavis from want and great suffering, with the view of humanity, the favorable manner his the said John Chavis' petition was received by your Honorable body, and on the faith and assertion of the above mentioned letter - your Petitioner was induced though in the midst of poverty himself with no other support than a good fame, to become security for the aforesaid poor old veteran to save him from starving, and in order to save the poor old man, as nearly become bankrupt himself – for before the promised Session which would have relieved his wants the said John Chavis was killed by the fall of a tree. Your Petitioner therefore prays your Honorable body to remunerate him for his charity to one so deserving your support as the aforesaid John Chavis – particularly when the same requisite is to be made as one hundred and ten Dollars
