I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Dear Sir

Captain Chitty the bearer of this has been with us most part of the last campaign as our principal guide. He has the most general knowledge of the Country of any man I know of. During his residence with the Army he has had the misfortune to lose several good horses; and lately a very valuable one. We still want him, but we have no means to procure him a horse, nor has he, which obliges me to apply to your Excellency to assist him. A bad horse will not answer as he is frequently exposed from the nature of the Service he has been employed in. His Singular merit and fidelity under the most trying and disagreeable Situation of things entitles him to some consideration and the service requiring his further assistance induces me to recommend him to your notice.
