Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2: Printed form of Indent No. 483 Book M dated October 1, 1784 "delivered to Mr. James Colk late a Private in Waters [Philemon Waters'] Troop Thomas [John Thomas'] Regiment Sumpters [Thomas Sumter's] Brigade of State Troops this our Indented Certificate for the Sum of Ninety Four pounds Sterling amount of pay and bounty due him for Services in the Troop with Interest thereon from the 1st of April 1782 to date hereof Agreeable to Resolution of General Assembly of 7th of March last."]

[pp 3-4: Reverse of the above Indent bearing the endorsements of Philemon Waters, Thomas Waters, G. F. Newmann, Thomas Sumter, Richard Richardson, and Peter Bocquet and John Edwards, the last 2 of which were the Commissioners of the South Carolina Treasury at the time this Indent was issued. There is no indication that the claimant ever signed or assigned his interest in the claim. How the above listed endorsers got an interest in the Indent is not stated in the documents in this file.]
