Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Senate & house of Representatives of the State of South Carolina The petition of John Cooper humbly Sheweth that your petitioner was a soldier during the Revolutionary War turned out as a Volunteer under Captain Nixon [John Nixon] at the Snowy Camps Captain Nixon's Company was Attached to General Richardson's [Richard Richardson's] Brigade. Then returned home. Then turned out under Lieutenant Adams [Alexander Adams] & went to Charleston to the Attack of Fort Moultrie [June 28, 1776] & there was till after the battle was over & then was discharged and came home. In 1779 I turned out at the Augusta Camp in Captain Nixon's Company who was Attached to Colonel Winn's Regiment & General Williamson's [Andrew Williamson's] Brigade. I then marched down the Savannah River on the Georgia side and Crossed & came to Stono and was there in Military service [presumably at the time of the Battle of Stono Ferry, June 20, 1779] then came home. After the fall of Charleston [Charleston South Carolina fell to the British on May 12, 1780] I turned out under Captain Adams [Samuel Adams] whose company was Attached to Colonel Lacey's [Edward Lacey's] Regiment & under General Sumter [Thomas Sumter] but was not at the battle of the hanging Rock [August 6, 1780] having the misfortune to lose my horse in the evening before we crossed the Catawba River but joined the Army at some distance above the hanging rock then marched down the River to Grave's Ford. Then after we heard of Gates Defeat [the defeat of the Southern D him ivision of the Continental Army under the command of General Horatio Gates at the Battle of Camden, August 15-16, 1780] we Retreated up the River & came home. I then removed to North Carolina & was on Military service of there. But a long lapse of time having expired I

He would state to your Honorable Body that he is now old & infirm in body & very subject to the gravel & seldom able to do any kind of labor he humbly prays your Honorable body to place him on the Pension list he having but slender claims on life being in the Seventy Sixth year of his age and your humble petitioner as ever in duty bound & will for ever pray &c
