I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The Senate & house of Representatives of the State of South Carolina Now Sitting in General Assembly, The Humble Petition of Joseph Corbett Humbly Sheweth, That your Petitioner, was wounded During the Late war by the Enemies of this State, he in the actual Service of the Same, & That Your Petitioner has made application agreeable to an Act of the General Assembly for that Purpose made & Provided, That Your Petitioner was Placed on the Pension List in due Time & That Your Petitioner has since made application to the Treasury for Payment without Success. Your Petitioner Therefore hopes, Your Honours will Take his case in Consideration & Grant him such relief as to your Honorable Body Shall Seem most Expedient, & Your Petitioner as in Duty bound will Ever Pray,
