Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



April 28<sup>th</sup> 1783 This Day personally appeared before me James Crawford a soldier in Colonel Wade Hampton's Regiment and Made oath as the Law Directs that by his Service in the State Troops of South Carolina Commanded by General Sumpter [Thomas Sumter] and the said James is Justly Entitled to one Negro according to the Terms of the Inlistment Made by the said General and that he the said James Crawford Did not violate this said Title nor Sell nor Dispose of the said Negro to any person whatsoever But James Maxwell now has Purchased the same from Me this Receipt shall be good to the Publick and to no other. Further the said Deponent Saith upon his Oath that he never Converted to his own Use public Horses Saddles or Bridles arms or ammunition of the Publick or Convey away more than what [undeciphered word or words] of in the Public Service and further Saith Not. Sworn to Before me the day and year above mentioned
