Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina Abbeville district } Personally came & appeared before me Mrs. Jane Crawford who being duly sworn Deposeth and saith that her first Husband William Lusk was Killed in the Actual service of this State on the 10th day of March 1781 & that he was a true friend to the American cause, that he left this deponent a widow with one child ten months old without any land or Negroes that she drew from the public treasury the child's annuity and her own for the year 1784 and afterwards for the child until it was twelve years of age but that she never drew any annuity for herself or child for the years 1781, 1782 & 1783 being the length of time which she was a Widow and that the public is Justly indented onto her three years annuities for herself and child, this Deponent further maketh oath that she is now a Widow and an inhabitant of the District Aforesaid, and in extremely Indigent Circumstances having no land or Negroes and a helpless family of six children to support

South Carolina – To the Honorable the President and other members of the Senate – The petition of Jean Crawford [sic] humbly Sheweth that her first Husband William Lusk was Killed in the actual Service of this State on the tenth day of March 1781 & that he was a friend to the American Cause – & your petitioner was left a widow with one child ten months old without any land or Negroes – your petitioner drew from the public treasury the Child's annuity and her own for the year 1784 – and afterwards for the Child until it was 12 years of age – but your petitioner never drew any annuity for herself or Child for the years 1781, 1782 & 1783 Being the length of time which She was a Widow – your petitioner is now a Widow and an inhabitant of the District of Abbeville in this State and in indigent Circumstances – your petitioner humbly prayeth your Honorable house to take her case into Consideration and grant such relief as you in your wisdom shall see meete [sic].

To the Honorable the Speaker and Members of the House of Representatives -

Your petitioner Humbly Sheweth that her late Husband John Crawford had during the Revolutionary war performed certain services for which he was Entitled to an Indent which indent was made out for your petitioner was drawn out by some person not entitled to the same – your petitioner therefore prays that this petition with the accompanying documents may be referred to the Comptroller General with directions for him to Report thereon to the next meeting of the legislature of this State so that Justice may be done in her petition as in duty bound will ever pray
