Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]







Salisbury North Carolina January 12th, 1785

Sir

I am Just Informed that there are some objections to the accounts against the public of South Carolina that are laid before you in my Name.

As to the Time I served as commissary I beg leave to inform you that I was Employed by John Galbraith Esquire, who was then a Quarter Master for that part where I served and was promised forty Silver Dollars each month

And as to the appraisements of the other property (Viz.) the Horses &c all the appraisements were taken from me when I was taken prisoner by the British at General Sumter's Surprise the 18th of August 1780 and all those that were the former appraisers are either dead or removed so that there are no others that were acquainted with the value of the Horses & wagons but those that last appraised them.

And as to the figures I was not acquainted with the mode of Drawing out public Accounts and did not know that the sum ought to have been in Letters

Therefore as I am conscious of the Justice of my accounts I hope you will take them into consideration and do me the Justice which you think I ought to have Major Crawford by whom this I expect this will be handed will further satisfy you further.
