Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

That they have investigated the allegations contained therein & find the same to be True & that the Petitioner is entitled to be provided for by Law & Recommend the Prayer of said Petition be Granted by allowing the Widow a Pension of five pounds per year during her Widow hood, – and the like Sum of five pounds to her only Child, until it arrives to the age of 12 years, should it live to that Time
