The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]





Captain Robert Anderson made oath before me that on the 10th day of February Last at Cherokee Ford Blockhouse having had Sundry Accounts of Colonels Boyd [James Boyd] & Moore's regiments of Tories who were then on their march near Cherokee Ford he thought necessary to send two spies to Bring Intelligence from the Enemy as he meant to do Every thing in his power to prevent their crossing Savannah River & accordingly agreed with Lieutenant Alexander Ramsey & William Curruthers [sic, William Carruthers?] to go, & for them on that Duty he ordered the above Mentioned horses & furniture to be taken, he further saith that said Lieutenant Ramsey & William Curruthers was made prisoners by the Enemy & confined as such till the Kettle Creek Battle² where they were rescued, but Believes the Enemy bore off the Horses & so that they could not be head
