Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[Note: This file contains documents relating to more than one veteran by this name. Use the page number of the file to identify the specific veteran to whom I believe the document relates. It is not always clear, however, which documents relate to specific veterans, so use my attribution with care.]

[p 11: Beginning on this page and running to page 32 are documents all relating to a pension granted to James Ramsey by the State of South Carolina at the rate of \$60 per annum based on the petition transcribed below. Most of the documents relate to the annual receipt of his pension and I have not transcribed those. Those receipts begin in 1826, so there must have been an earlier petition than that included in this file.]

To the Honorable the Senate and House of Representatives –

The humble petition of James Ramsey Sheweth that he was a soldier of the revolution, that he enlisted in the year 1778 as well as he recollects, that he served three years & six months in the State of South Carolina, commanded by Colonel Alkershaw² [sic?] he was not in any General engagement, but frequent alarms were given & he often paraded expecting to have an engagement –

That he is now 75 years old and quite infirm and therefore prays your Honorable Body to take his case into consideration and grant him such assistance as shall seem proper to your Honorable body and your Petitioner will ever pray.

24th of November 1836
