The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Petition of John Davis praying to be placed on the Pension List

To the Honorable the Senate and House of Representatives in Session at Columbia Gentlemen

Your petitioner by this his petition would show, that he enlisted in the service of his country some time in the year 1781 for the term of 10 months under the command of Captain James Giles, Colonel William Hill's Regiment of State Troops and commanded by General Sumpter [Thomas Sumter]; that he marched into South Carolina where he performed the principal part of his service, that he served out his time faithfully and was regularly discharged at Orangeburg, that he has lost his discharge not thinking it would be of any use to him, that he is now sixty-nine years of age, and his wife is sixty-eight years of age, that their children are all gone from them and he is now old and poor.

Your petitioner scorned to ask for any help while he could support himself, but the combined effects of Poverty & old age compell him to ask for a support at your hand, believing that the State of South Carolina will not Suffer him to want who gave her a warm support in her struggle for Independence, he hopes you will grant him some Relief and your petitioner as in duty bound will ever pray

South Carolina Abbeville District Personally came before me the Subscribing Justice Henry Livingston of this District aged sixty-eight years, and on being duly sworn on his oath does declare that he was well acquainted with the within petitioner John Davis during the Revolutionary War, that he became acquainted with him in the camps, that the [sic, he] Served in Captain Giles Co. of infantry Colonel Hill's Regiment of ten months men under the command of General Sumpter, that he served out his time faithfully and was a good Soldier for his country that he served almost all his time in the State of South Carolina and that he does believe him to be a fit subject of the pension list.

To the Honorable Senate and House of Representatives in Session at Columbia

Gentlemen your Petitioner by this her petition would show that She is the widow of John Davis, Deceased, late a pensioner of this State that her husband John Davis was placed on the pension list at your last Session drew his pension in February last and died on or about the first of September last leaving your petitioner in a very distressed situation having no children of her own, nor any Blood relation in this country to go to for the least assistance in her poverty and distress – your petitioner would further show that she is now sixty-seven years of age and not a very stout habits and that she is laboring under severe afflictions from a cancer on her breast which will in all human probabilities put a period to her existence ere long.

She would further show that when the debts of her deceased husband are paid out of what little he left there will remain nothing to support on your petitioner's behalf that if everything be sold, as they will shortly be, to pay the debts there will be very trifling if anything left

Thus situated she presents herself to the Honorable Legislature of South Carolina as her last resort, to save her from the horrors of a poor house which she thinks was never intended for a soldier's wife, or widow, She therefore prays the Legislature to grant her the pension that was given to her deceased husband and place her on the pension list and allow her such Sum as in your wisdom you may see fit –

and your petitioner as in duty bound will ever pray. 7^{th} November 1831
