[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The Humble Petition of Joshua Davis

Sheweth

That your Petitioner was Drafted in the Service of the United States in the Revolutionary War at the age of Sixteen & that he served Occasionally until he was twenty-one Years of Age. Your Petitioner was Enlisted in Colonel Maham's [Hezekiah Maham's] Regiment of Cavalry for the Term of one year for which he received his regular pay it being [?] the only consideration he received for his Services during the Term of Five Years.

Your Petitioner now being old & infirm and unable to support himself by labor Prays your Honorable Body to Place him on the Pension Roll and Your Petitioner will ever pray &c

Personally came before me Joshua Davis & being duly Sworn saith that he Served Occasionally in the Militia of the United States in the Revolutionary War for the Term of Four years & That he served in Colonel Maham's Regiment of Cavalry for the term of one Year, and that he never received but one year's pay
