Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.1

[p 2: Printed form of indent No. 326 Book C dated April 20th, 1784 "delivered to Mr. James Dick late of the Frigate South Carolina this our Indented Certificate for the Sum of One hundred & twelve pounds seven Shillings and three pence Sterling for Balance of Wages due him as Midshipmen on board the said Frigate and for one Years full pay, he having been in France with Commodore Gillon [Alexander Gillon], and served on board and returned in the said Ship as per Certificate from the Auditor General of this date."

I do hereby Assign over unto Mr. Alexander Gillon his heirs, Executors, Administrators & Assigns, All my right Title Interest & Claim to the within Indent.
