Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all men by these presents that I Evan Shelby has sold my Right of a certain Negro to Joseph McCane which Negro was the draw of a certain Daniel Stewart which faithfully served ten months in South Carolina in General Sumpters [Thomas Sumter's] State service – and said Stewart has been qualified that he never plundered During the term of time – and I the said Evan Shelby do hereby make Joseph McCane the sole and prior Right to the aforesaid Draw in consideration of eighty pounds hard currency to me in hand paid by the said Joseph McCane – provided nevertheless if the said Daniel Stewart has forfeited his Right to the above mentioned [text obliterated and rendered illegible] plundering or otherwise, I do hereby oblige myself to make the said Joseph McCane whole – Given under my hand this 10th Day of May 1783

This day personally came before me Captain William Alexander and made oath that he saw Daniel Stewart sell and make over his Right to his ten month Tower [tour] in General Sumter's brigade of State Troops of South Carolina to George Reed and said George Reed made over the same in his hand to Evan Shelby and said Evan Shelby made over the same to Joseph McCain
