Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all men by these presents that I John Mitchell of North Carolina, Mecklenburg County, have [several lines of text compromised and rendered undecipherable in any meaningful way) Thomas Nichol of State & County aforesaid the Receipt whereof I do hereby acknowledge have bargained & sold & by these presents, I the said John Mitchell [for] my heirs & assigns do bargain & sell unto the said Nichol his heirs & assigns forever my full right of the Negro who is due to me from South Carolina for my services done in State Troops [several more lines of the document rendered undecipherable in any meaningful degree] property, or whatever can be had for the said services which I did in the state troop campaign & I the said Mitchell do warrant the chance of said Negro, money or property, free from the encumbrances of any bargain prior to this one, or any that shall be made by me, the said Mitchell & for the performance of this contract I the said Mitchell do bind myself, my heirs or assigns in the penal sum of one hundred and forty pounds payable [several words obliterated] upon demand [several words obliterated] of nonperformance [one or more words obliterated] bargained. Given under my hand this 2<sup>nd</sup> November 1783
