Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



To the Honorable the President and Members of the Senate now Met and Sitting in General Assembly

The Petition of the undersigned Humbly Sheweth.

That your Petitioner was Entitled to two Indents No. 226 and 258² which Indents was made out in due form for services rendered by your petitioner in the Revolutionary War and for which your petitioner has never received any Compensation whatever. Your Petitioner applied some years since for his Indents when he was informed that the two aforesaid Indents had been drawn from that office by a Mr. Robert Smith and that your petitioner must apply to said Smith for redress.

Your Petitioner has never been able to get any Compensation for said Indents, and humbly hopes as the Officers of the State has permitted his two Indents to be drawn from the Treasury without his Order or consent, that he may now be paid for the same. The accompanying documents will fully proved the Justness of your petitioner's Claim.

And your Petitioner as in duty bound will ever Pray &c
