Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Humbly Sheweth, that an Indent was filled up for the Amount of Ten Pounds 7/2 [Seven Shillings and two pence] due to him as a Private in General Sumpters [Thomas Sumter's] Brigade [of ten months State Troops], and at the said General's desire received in the Office until your Petitioner applied for it, but from Unavoidable Circumstances, he was prevented from Making Application within the time directed, since which the Indent has been Sent to Charleston – Your Petitioner therefore prays that leave be Given for the Indent to be Issued, and your Petitioner as in Duty Bound will ever pray

Resolved, that William Hill, of Fishing Creek, in York County, be, and he is, hereby authorized and empowered to receive from the Public Offices of this State an Indent granted to him for Ten pounds Seven Shillings and two pence No. 272, Book B. Provided it shall appear to the satisfaction of the Officer delivering the same, that such Indent hath not heretofore been issued.
