Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Personally came Frederick Lipham & made oath Before me that about October 1780 being on Duty as a purchasing Commissary for General Sumter's Brigade in Mecklenburg County near the Catawba River the above mentioned horse was taken from him by the Enemy, that he never Since has got him, nor Received any Pay, that the said horse previous to his being taken was appraised by General Sumter's Orders at Six thousand Dollars in Depreciated Currency & further that, the said horse Cost him one Hundred & fifty pounds old Currency in Specie, which sum he thinks [it] was well worth.
