Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." [Sterling] being residue of balance pay and Bounty due him for Services in that Troop together with Interest thereon from the first April 1782 to date hereof Agreeable to a Resolution of General Assembly of the Eleventh March last."]
