Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

This Day Francis Rackley made oath Before me a Justice for said that he served Ten Months as a Light Dragoon in the State of South Carolina in General Sumters [Thomas Sumter's] Brigade in Captain William McKinsey's [William McKenzie's] Company for which he is entitled to a good Likely grown nagra [Negro] and all the Clothing for which he has Never Received any Valey [Value] from the State of South Carolina and he further saith on oath that he Never Before Sold nor Disposed of the said Nagra nor Clothing to any person or persons but to Robert Alexander for which I have Received of him full Valoy [value] and Do Warrant the said Nagra and Clothing to the said Robert Alexander to be Without any fraud. Sworn and given under my hand this 5th day of March 1785

Gentlemen Commissioners please to pay Robert Alexander the Nagra and Clothing that I am Entitled to for my ten months Service as a Light Dragoon under the Command of General Sumter in the State of South Carolina and this shall be your Discharge in full of all Demands against the said State of South Carolina. 
