The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Speaker and other Members of the House of Representatives of the State of South Carolina

The Petition of Abraham Livingston Sheweth That your Petitioner has served in the State Troop ten months Service of the aforesaid State during the late American revolutionary Struggle for which Service he was entitled to receive £86.10.8 as per Act of the General Assembly of the said State and his Clothing

That he hath received in part pay of the Same to the amount of £45.7.6 in a small Negro and part his Clothing. That there still remains due him the sum of Forty-seven Pounds Nineteen Shillings with Interest thereon as per Account within exhibited. That he hath made Application from time to time and in divers ways for the Balance of said Account and hath never received any Compensation for the same either in money discount Indent Certificate or otherwise, other than General Sumter's [Thomas Sumter's] certificate herewith shown. That he rendered his Account previous to the 1st of October 1801, And that the Comptroller hath remarked on the papers accompanying this petition "that the same is Baned [sic] by law" Notwithstanding General Sumter's Certificate to the Contrary:

Wherefore your petitioner prays that you would take his case under your Consideration and Grant him such relief and redress as the reason and Justice of his Claim may require, And your petitioner as in duty bound will ever pray.

State of South Carolina

To the Honorable the President and other Members of the Senate of the State aforesaid now met and Sitting in General Assembly –

The petition of Abraham Livingston – Humbly Sheweth – That your petitioner hath served in the state troop ten months service of said State during the late American Revolution for which Service he was entitled to receive eighty-six pounds ten shillings and eight pence as per Act of the General Assembly of this State and his Clothing –

That he hath received in part pay of the same to the Amount of forty-five pounds seven Shillings and six pence in a small Negro and part his Clothing – That there still remains due him the sum of forty-seven pounds nineteen Shillings with interest thereon as per Account herewith exhibited – That he hath made application from time to time and in divers ways for the balance of said Account, and has never received any compensation for the same in money, Property, indent or certificates other than General Sumter certificate herewith shown – That he rendered his account into the Comptroller previous to the 1st of October 1801, That your Petitioner at the Session following preferred a petition praying payments the same was referred to the Comptroller who reported to the Session of the Legislature in 1802 in the following words viz.

"State of South Carolina

To the Honorable Robert Starke Speaker and other members of the House of Representatives of the State aforesaid, the Comptroller General on the Petition of Abraham Livingston specially referred at the last Session of the Legislature Reports – That having carefully examined the pay Rolls of Sumter's Brigade he finds that the petitioner is entitled to the amount of the balance account which is two hundred and five dollars and fifty cents for which he has never received an Indent. It is therefore recommended that this amount with interest from the 26th of March 1784 be allowed him, that being the date from which interest has always been allowed on such Claims, and that provision be made for this among the registered claims – respectfully submitted

by Paul Hamilton, Comptroller General"





I do hereby certify that Abraham Livingston a Soldier transferred from Colonel Hill's Regiment into that commanded by me was wounded [at the Battle of the Eutaw]² and was sent to Hospital & there continued until the expiration of the service, not having recovered of his wound & is

entitled to pay agreeably to the enlistment.

To the Honorable the Speaker and other members of house of Representatives now met and sitting in General Assembly at Columbia Gentlemen

Your petitioner by this his petition would show that he was a soldier of the revolutionary war that he served in the militia under Captain Coffey in the Waxhaw's settlement at or about the time of the fall of Charleston they went into North Carolina refugeeing and again entered the militia service under Captain Taggart [Joseph Taggert of the Mecklenburg County North Carolina militia] under whom he served out his tour of service that he then enlisted in Colonel Hill's Regiment of ten months from which he was transferred to Colonel Polk's Regiment and was severely wounded & sent to the hospital as will more fully appear by a reference being had to the certificate of Colonel William Polk herewith submitted that he is now very old and infirm and utterly unable to support himself by labor, that he is now however reluctantly compelled to ask the State of South Carolina to support him in his declining life and finally hopes he will not be neglected.

That whilst he was able to work for his own support he scorned to ask for relief, but old age and poverty have overtaken him and compelled him to make this application and as he is now in very needy circumstances he fondly hopes you will allow him some arrearages of pension such as will comport with the generosity and liberality of the State and that he be permanently placed on the pension list and your petitioner as in duty bound will ever pray
