I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." North Carolina Rowan County} This day came William Earewood [sic] one of the man who Served ten months in the State of South Carolina in Captain William Alexander's Company Colonel Wade Hampton's Regiment & General Sumpters [Thomas Sumter's] Brigade in the year 1781 and made oath that he did not take Any of the Publick Property of the State of South Carolina nor any Private Property of Any Person an Inhabitant of said State to convert it to his own use or the use of any other Person nor Convey it away himself or Cause it to be Conveyed out of the said State to the Prejudice of the Publick or Any Individual Sworn & Subscribed this 3rd day of February 1783 before me Justice of the peace for said County
