Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all men by these presents that I John Larinis Fubuhur [sic] Soldier in the State Troops under command of Colonel Henry Hampton hath Sold & made over Unto James Jack Lieutenant under Command of General Sumter [Thomas Sumter] my Right of a Negro Due to me for my Services During the term of ten months for the Consideration of sixty pounds to me in hand paid & I the said febigur [sic] Doth acknowledge my Self therewith fully Satisfied as Witness My hand this day and year above written

Please deliver to Captain James Jack the Negro I am to receive for my service in the State Troops in your Regiment
