Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.1

Know all Men by these presents that I William Proudlove Private Soldier of the South Carolina State Troops in the Regiment commanded by Colonel Wade Hampton [sic, Henry Hampton] and Captain John Mills' Troop of Light Dragoons I have bargained and Sold and by these presents for me my Heirs, Executors, administrators do bargain Sell and make over one Negro which I am to receive from the publick for my service unto Robert Harper of the State of South Carolina in Camden District planter to him his heirs, executors or assigns for the consideration of one Sorrel Mare and one Sorrel filly Two years old with some clothing To him in hand paid for which I the above mentioned William Proudlove doth Deliver the said grown Negro unto the above said Robert Harper his heirs Executors or assigns clear of all claims sale or mortgage to be the above said Robert Harper's property for ever Given under my hand this 27<sup>th</sup> Day of September 1781 and the sixth year of the independency of America Signed Sealed and Delivered in Presence S/ Alexander Brown
