Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



The State of South Carolina

To the Honorable President and members of the Senate of the state of South Carolina, The Humble petition of Drury Harris a resident in the District of Richland and state aforesaid, Sheweth that he was an enlisted Soldier in the Revolutionary war, in the third Regiment of the state of South Carolina him by Colonel William Thompson [William Thomson], and received two wounds in the battle of Savannah,² which now he is growing old renders him unable to make a support for himself & family, your humble petitioner further state that as long as he was able to labor for the support of himself and family he did not call on the Public for Assistance but he is now about Sixty Eight Years old and of course must grow more infirm, therefore humbly prays that your Honorable body will take his case into consideration and place him on the Pension list and allow him some arrears of Pension or such other relief as your Honorable [body] may think fit – and your petitioner will ever pray

South Carolina Richland District } Personally appeared Before me John Marshall one of the Justices Assigned to keep the peace in and for the District aforesaid, Drury Harris, who made Oath that he served in the Revolutionary War, in the Regiment of Colonel William Thompson, and in the Company of Captain George Little [George Liddell] In which Service he received two wounds, one in the Arm & the other in the Thigh, whereby he is much disabled at this time – Also that he had served under Captain Rich Browne [Richard Brown] – Sworn to before me this 11th November 1817 S/ John Marshel, JP S/ Drury Harris, X his mark

North Carolina Anson County}

Drury Harris wrote to me for his Recommendation of his Conduct and behavior whilst he was in the 3rd Regiment of South Carolina, in our first Revolutionary war, I John Davis do certify this, who was a Soldier in the Regiment and Company that Drury Harris belong[ed] to who was first Sergeant also was Sergeant of the Platoon, that Drury Harris belong[ed] to, in the fight at Savanna I saw no man, officer nor private more Activer [sic] nor braver than Drury Harris who also Seeing and Knowing him, to receive two wounds, a shot wound in the thigh, and a bayonet in the arm, in trying to Seal the walls of his Enemy, which I will say, now he is old, of course not able to Labor hard, if there is any old Soldier Deserves any assistance from the Public Drury Harris does.



State of South Carolina Richland District } Personally appeared Gidden Griffin³ before me M. Patterson one of the Justices of the peace in and for the District aforesaid and makes oath that he is well acquainted with Drury Harris and that he knew him to be a listed Soldier in the last Revolutionary war and that he knew him the said Harris to get wounded at the battle of Savannah and further this deponent saith not.

Sworn to before me this 20th day of January 1815 S/ M. Patterson, JP S/ Gidden Griffin, X his mark

Richland District} I hereby Certify that Drury Harris Served as an Enlisted Soldier in the 3rd Regiment of South Carolina Commanded by Colonel William Thompson that I knew him to be as such.

The Committee on Pensions to whom was referred the petition of Drury Harris praying to be placed on the pension list

Report – that they have had the same under Consideration and recommend that the said Drury Harris be placed on the pension list and allowed the sum of sixty dollars per annum during life and five pounds Sterling for 5 years in arrears of pension
