Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

This is to Certify that I have sold unto Messrs Myddelton & Hart a Negro due to me by the public of South Carolina for Ten Months Service in the State Troops General Sumters Thomas Sumter's] Brigade Colonel Wade Hampton's Regiment and I do further Acknowledge I have received the Sum of fifty Guineas in full for the Negro & all other perquisites, prize monies &c due me for said Service in Witness whereof I have set my hand this  $27^{th}$  [could be  $29^{th}$ ] September 1783
