

The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

In my letter to your Excellency from George Town [Georgetown] I omitted Mentioning the Cloathing for myself & Officers during their Continental Cavalry Service, which I hope your Excellency will think our due & Get the Assembly to allow the same, Indeed myself which have been almost Constantly in the field since January 1780 have received none since that time & this Expense I have felt very severely Since that period – and am with the Utmost Respect Santee 6th March 1783

Notwithstanding which your Petitioners find that they have been Considered Officers of this State only, by which means the State has been burdened with the Expense of your Petitioner's deprived of the Advantages which Officers in the Continental Service have obtained. They therefor for themselves & in behalf of the Officers of their Respective regiments Request your Honorable House, that you will Examine into the Merits of their Claims [text written over and rendered illegible] your Petitioner's [text written over and rendered illegible] General Government [text written over and rendered illegible]

That upon investigation to the same, or of Opinion that the powers given to General Green by the Resolution of Congress of 18 September 1781 that they ought to be considered as Continental Officers, and therefor recommend that our Delegates to the Senate & House of Representatives to the General Government be desired to support the claims and applications of Colonels Maham & Horry to obtain compensation for themselves and Officers from the General Government –

The Petition of the Subscribers Humbly Sheweth

That in the late Glorious Contest between America and Great Britain your Petitioners enlisted in the service of the State as State Troops under the Command of Colonel Peter Horry for the time mentioned by him in the Account rendered into the Auditor General's Office in March 1783 and your petitioners being ignorant of the mode of obtaining the Certificates for their Services (until the time had elapsed by Law to draw the same) take this method of submitting the Hardships of their Situation to your consideration, and also beseech you to consider the Indigence of their Circumstances, and order the Treasurer to grant each of them a Certificate so that they may obtain an Indent for the Amount of pay due them for the above Mentioned Services – and your petitioners as in duty bound will ever pray

That your Petitioner served as Soldiers in Colonel Peter Horry's Corps of Light dragoons in the defense of their Country for a Considerable time during the Late War with Great Britain, a certificate of which service accompanies this petition —

Your Petitioners therefor Humbly entreat your Honorable House to take their Case into Consideration and Grant them Such Compensation for their Services as in your Wisdom shall seem Meet²¹ –

²¹ In Samuel Johnson's Dictionary of 1755, the first definition of the word "meet" he gives is "Fit; proper....". Johnson noted that even at that time the word "meet" was rarely so used. It must have become fairly popular in South Carolina in the early 1800's, however, as it appears in many petitions submitted to the SC Legislature.
