Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2: Printed form of Indent No. 550 Book In dated April 14th, 1785 "delivered to Mr. John Morgan this our Indented Certificate for the Sum of Eighty One Pounds Eleven Shillings and six Pence three farthings Sterling for 12 Months Pay due him as Armorer in Colonel Horry's [Peter Horry's] Regiment of Cavalry in 1782 as per Account Audited."]

To the Honorable the President & the rest of the Members of the Senate –

The petition of Judith Morgan humbly Sheweth that John Morgan deceased your petitioner's late husband was a Soldier in the first Regiment of Continental troops on the South Carolina Establishment commanded by Brigadier General Charles C. Pinckney; and that he (your petitioner's husband) neglected to render in his account against the public for duty as Armorer within the time required by law, owing to his being ignorant of such an existing law, by which neglect his account was not audited —

Your petitioner further Sheweth that she was left in very necessitous circumstances. Therefor humbly prays that she may be afforded such relief as you in your wisdom shall think proper: & your petitioner as in duty bound ever pray &c
