Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Myddelton's] Regiment Sumpter's [Thomas Sumter's] Brigade this our Indented Certificate for the Sum of Ninety-four pounds Sterling being amount pay and bounty due him for Services in that Troop Together with Interest thereon from the first April 1782 to date hereof Agreeable to Resolution of General Assembly of the Eleventh March last."]
- [p 5: Reverse of the above Indent bearing numerous endorsements but none by the Veteran. The endorsers are Peter Bocquet, Commissioner of the South Carolina Treasury, Griffith Rutherford, Richard Richardson, William Henderson, Henry Haynsworth and Samuel Reynolds. How these men acquired an interest in the Indent is not disclosed by the documents in this file.]
