Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.1

South Carolina Pendleton County Before me John Willson one of the Justices of the Peace for the County aforesaid Personally Came James Swan[sic] and being Duly Sworn and on oath saith that he was wounded in his shoulder in or about the month of August in the year 1780 in the service of said State under the Command of Col. James Williams and by Reason of said Wound he is not able to Labour for the suport of himself and family as formerly and that he owns but two hundred acres of poore Lands and one small Negroe and that he was at that time a Citizen of said State and hath Continued so since to this time and that he was still a friend to this Country. Sworn and subscribed the 26th day of January 1796 before me S/ John Willson, JP

To ye Honorable Speaker and Members of the House of Representatives Convened at Columbia on the 4th Monday in November Next.

To the Honorable the Speaker & Members of the House of Representatives to meet at Columbia on the 4^{th} Monday of November next; The Remonstrance and Pettition of y^r Subscriber living in Pendleton County; Humbly Sheweth your Pettitioner is & have long been entitled to an Annuity agreeable to the Laws of ye State in y^t Case & Provided y^t Notwithstanding his right to Apply (having as will appear by ye Vouchers² accompanying this Petition) been actually wounded in the Wars; & notwithstanding his still having been in need of y^t relief and Assistance in supporting his Family which has been granted to others; Yet ye Petitioner hopes and Humbly prays y^t your Honorable House will Vote him that allowance which he humbly presumes he has a Legal right to claim as coming in at y^t eleventh hour.

And y^r Pettitioner as in duty bound shall ever pray
