Know all Men by these Presents that I Constant Harrison of Camden District and of the State of South Carolina have made over Bargained and sold all my right title and Claim of the Negroe which I am Entitled to draw for ten Months Service in the State Troops of South Carolina in General Sumpters [Thomas Sumter's] Brigade to David Hart of the County of Mecklenburg and State of North Carolina for and in consideration of the Sum of Ten Guineas in hand paid I ^{bind} myself my Heirs, Executors, Administrators and assignees firmly by these presents do warrant [paper damaged and text obliterated] and the said Negroe to be the property of said Hart his heirs Executors Administrators and Assigns as Witness my hand and Seal this 9th Day of November 1782 and in the 7th Year of our Independence.


