Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

I do hereby Bind my Self my heirs and Executors I or Either of them to appear at the place of Rendezvous of the State Troops then and there to deliver to Jeames McGonn one certain Negro to be drawn by me John Oins [John Owens] for the Service of the said John Oins the said Negro to be delivered to James McGonne [sic] for and in Consideration of certain Ronin [Roan] horse and Saddle now delivered before the signing of these presents this given under my hand and seal this 13th day of February 1782

That your Petitioner is Attorney of John Owens formerly a Dragoon in the Service of the State of South Carolina under Captain Godfrey Adams & Captain Richard Moore in the 2nd Regiment of Dragoons under the command of Charles Middleton who was regularly discharged on the 18th day of April 1782 by the said Colonel Charles Middleton after 11 Months faithful

Service, as will more fully appear by the Power of Attorney & Discharge aforesaid, accompanying this Petition – And your Petitioner further states that the said John Owens never has received Satisfaction for the same, or legally authorized any other person except Colonel John Carson to draw pay for the same, & that the said John Owens was wounded in the said Service at the Eutaw Springs [September 8, 1781], under the command of General Sumter as May more fully appear by the affidavit of the said John Owen taken the 29th January 1810 –

Your Petitioner therefor respectfully prays your Honorable House to take his Case into consideration, and grant him such relief as may comport with the Justice & liberality of the State to its Revolutionary Defenders –

And your Petitioner as in duty bound will ever pray & so forth
