The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2: Form of Indent dated 28th May 1785 Indent No. 338, Book R issued to the Estate of Mr. Daniel Andrews in the amount of "Twenty-Nine Pounds Eighteen Shillings and ten Pence halfpenny Sterling for 17 1/2 Months Pay due him as Corporal in the South Carolina Regiment in 1779 and 1781 as per Audited Account." Jane Andrews is named in the indent as the executrix of the estate.]


