The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all men by these [text too faint to discern] that I Samuel Hemphill of the State of [text too faint to discern] Richman [sic, Richmond] County have & do by these presents [text written over and rendered illegible] that William Hemphill is Made in My Behalf & By these Presents do [illegibly faint word] and appoint My trusty and will [sic, well] Beloved friend William Alexander My true & faithful Attorney for my Self [undeciphered word] and [text written over and rendered illegible] for a Sertin [sic, certain] Nagrow [sic, Negro] Draw that is In [sic] due Me By the State of South Carolina for my Services as Lieutenant in said State. Given under my hand and Seal this 17 of April 1784
