Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." To the Honorable the House of Representatives, Vizt. His Honor the Speaker & the rest of ye Members

The Petition of Robert Shields,

Humbly Sheweth,

That your Petitioner was a Soldier in the Regiment of State Troops under Colonel [sic Lt. Col.] William Polk in the Service of the State of South Carolina & in the Year 1781, was wounded in Action in defense of the Same; that he is thereby rendered unable to maintain himself, & thinks he comes within the Meaning & Purview of the Resolves of the General Assembly passed the 15 of March 1786 provided for the Relief of Persons disabled in Defense of the State; that he applied to William Hort Esquire; Treasurer who informed that your Petitioner, he could do nothing & referred him to apply by petition to the General Assembly; which he now does, beseeching your Honorable House to Take the Premises into your Serious Consideration and to grant him such Relief, as you in your Wisdom shall seem meet,<sup>2</sup> and your Petitioner as in Duty bound will ever pray and so forth. <sup>&</sup>lt;sup>2</sup> In Samuel Johnson's Dictionary of 1755, the first definition of the word "meet" he gives is "Fit; proper....". Johnson noted that even at that time the word "meet" was rarely so used. It must have become fairly popular in South Carolina in the early 1800's, however, as it appears in many petitions submitted to the SC Legislature.
