I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina Mecklenburg County

I William Hutchison late a Captain in General Sumpters [Thomas Sumter's] Brigade of State Troops, do hereby certify that I was present and did see drawn and delivered unto Thomas Williams a Soldier in my Troop a Negro Winch named Sue otherwise called Rachel for his services for ten months agreeably to the enlistment of the troops of the said Brigade & I do furthermore certify that to my own knowledge the said Negro Winch was sold by the Executor of the said Thomas Williams to James Kennedy & by James Kennedy unto Major John Davidson all of the aforesaid County; and that whilst in possession of M. Davidson a suit was instituted against him by a certain William Baylstone of South Carolina in Salisbury Superior Court, and there did prove the property of the said Negro to have been in him and never transferred but Mr. Davidson proved by my oath and other testimony to the satisfaction of the said Court that the Negro aforesaid had been legally drawn and delivered to the said Williams for his services agreeably to the Laws of South Carolina, and in conformity to an Ordinance of this State confirming that Law – Judgment was then and there given for the Defendant John Davidson.
