I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina Mecklenburg County D [Dec. or J for January ?] 1st 1886 [sic, 1786]} This will certify that I have sold my Title to my ten months Tower [tour] in General Sumpters [Thomas Sumter's] brigade of State troops in the State of South Carolina with the Clothing and every other advantage which may arise from said Tower. I do hereby assign it to John Woodside for and in Consideration of Eighty pounds Currency of the State of North Carolina the Receipt of which I hereby acknowledge and will warrant said Tower to be faithfully done and to good acceptance and do hereby Empower said Wooside [sic] to receive the Indent or such other pay as the Commissioners of the State of South Carolina may pay said service.
