The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all men by these presence that I Abraham Livingston am held and firmly Bound unto Robert Irwin in the full Sum of one Hundred pounds specie for which payment well and truly to be made and Done I bind myself my heirs Executors and administrators firmly by these presence And With my sent [?] and Dated this 2<sup>nd</sup> day of June 1783

The Condition of the above obligation is such that Whereas the above Named Robert Irwin hath Bought of the above Named Abraham Livingston a Negro Which is Due to Jesse Robinett in Consequence of his service as a Soldier in the State Troops of South Carolina Under Brigadier General Sumter and the said Livingston doth hereby Bind himself to maintain [several undeciphered words] to be Due to the said Jesse Robinett and also [undeciphered word] the same or other property in lieu thereof shall be Drawn from the Public to convey the same to the said Robert Irwin By a bill of sale or otherwise sufficient to Vest the Property thereof in the said Robert Irwin and then and in that Case the above obligation to be Void, otherwise to Remain in full force and Virtue According – Signed Sealed and Delivered
