Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know Ye to Whom it May concern That I James Turner of Colonel Middleton's [Charles S Myddelton's] Regiment of Light Dragoons & Captain Waters [Philemon Waters] Troop have this Day Bargained, Sold & Made Over to the said Captain Waters My Right & Claim against ye Public for one grown Negro according to General Sumters [Brigadier General Thomas Sumter's] [one or more undeciphered words] of a grown Negro to each Private that he enlisted himself and faithfully served in the State Troops for the space of ten Months Giving him Power to Draw my Draft to lock [?] and keep ye above Negro. By these Presents [I] Do acquit him the said Waters [undeciphered words] of any Claim or Claims to ye Negro by Me my Heirs or assigns as witness my Hand this 8<sup>th</sup> Day of November 1781
