Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]


Petition of John Cook praying Compensation for a Negro killed in the Revolutionary War Wm F. Pearson, Chairman

To the Honorable the Speaker and Members of the house of Representatives

The humble petition of John Cook a citizen of the State of Georgia, respectfully Sheweth unto your Honorable body; that he intermarried with Mary Ellen Hampton, the reputed and acknowledged daughter of Colonel Edward Hampton, who was killed in an action with the Tories near Fairforest in the war of the Revolution – that by the last will and testament of George Dawkins, Sr. the maternal grandfather of your petitioner's wife, she became entitled to a certain Negro man, by name Ellis, – that in the spring of the year 1780, or 1781, the said Negro Ellis was mortally wounded by a party of American Militia under the command of Colonel James Lyles, who were in pursuit of certain persons known to be inimical to the cause of this country – the said Negro mistaking his friends & endeavoring to make his escape was in consequence killed; by which the orphan child of a known and warm friend of his country – who had sacrificed his life for liberty, and left a helpless offspring to the Liberty of the world. For this accidental misfortune your petitioner's wife has never received any kind of remuneration. The facts are well established by the documents herewith submitted. Your petitioner prays for some indemnification in right of his wife; and for this he puts himself on the generosity of your Honorable body ever trusting in your wisdom &c

Georgia Baldwin County Personally came and appeared before me a Justice of the peace for Putman County William D. Lane Esquire a member of the Senate of the legislature of this State, now in session, who being Sworn as the Law directs saith on his oath that he has had an intimate knowledge of, and with John Cook, and also with the Mary Ellen Cook his wife that they were nearly raised from childhood together, and that she was the reputed and acknowledged daughter of Colonel Edward Hampton, who was said to have been killed in an action with the Tories near Fairforest in South Carolina during the War of the revolution, and deponent saith that he had his information of Colonel Hampton's Death from eyewitness, viz., Captain Daniel McDuff. Deponent further saith that he has a perfect recollection that during the said War of the revolution – (he cannot be certain as to dates) but he thinks in the spring of the year 1780 or 1781, that a Negro fellow named Ellis the property of said Mary Ellen Hampton, now Mary Ellen Cook, was mortally wounded by a party of the American Militia under the command of Colonel James Liles. – Deponent saw the Negro in a few minutes after he was wounded, and he believes every day thereafter until he died, which was in a very few days – He perfectly recollects that at the time of this transaction, it was generally the conversation – that it happened by the Negroe's being mistaken, when running from the party for a white men of whom they were in pursuit that was inimical to the cause of the country, from what he can remember. Deponent is firmly of opinion that the Negro was killed by a man of this party through mistake, and that the circumstance took place on Grimes Creek now in Newberry District near Broad River. And that the said Negro Ellis was with Easter (or Hester) his sister given to the afore named Mary Ellen Hampton – (now Cook) by the last will & testament of George Dawkins Senior her Maternal Grandfather, which will was recorded in the office of Newberry County Court many years ago. Deponent further saith that the said Negro so killed was a remarkably valuable Slave such as at present he believes would sell for five or six hundred Dollars and was at that time the better half of what property the said Mary E. Hampton inherited or claimed. Deponent further saith that he never heard of any suit being commenced for the recovering the value of said Negro, and believes there never was any he also says that the officer said at that time to command has been many years did and from a concurrence of Circumstances he does not suppose that it would be possible for any recovery to be had. This concern was of public notoriety and appeared to be matter of regret by the party and of the neighborhood generally on account of being the property of a daughter of Colonel E. Hampton an officer Generally and most deservedly beloved by his fellow citizens generally.

The foregoing declaration and deposition was Solemnly affirmed and Sworn to before me on this the 8th day of November in the year of our Lord 1815 before me
